in FIG. 8;

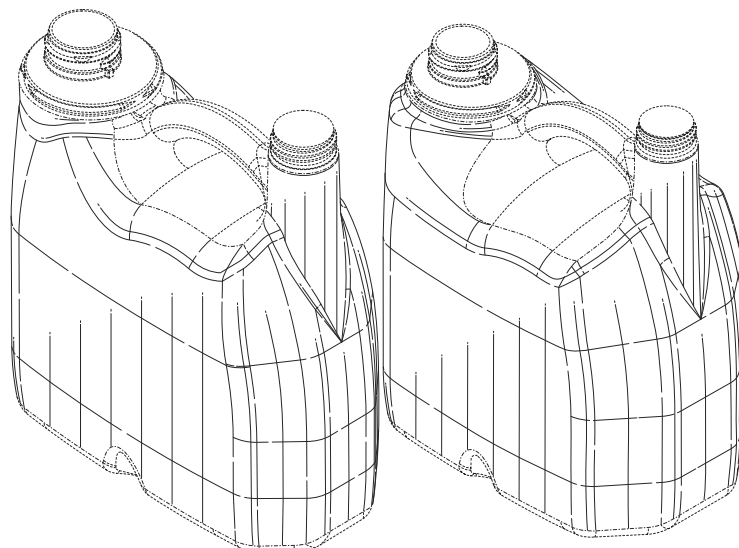
FIG. 12 is a right side elevational view of the container seen

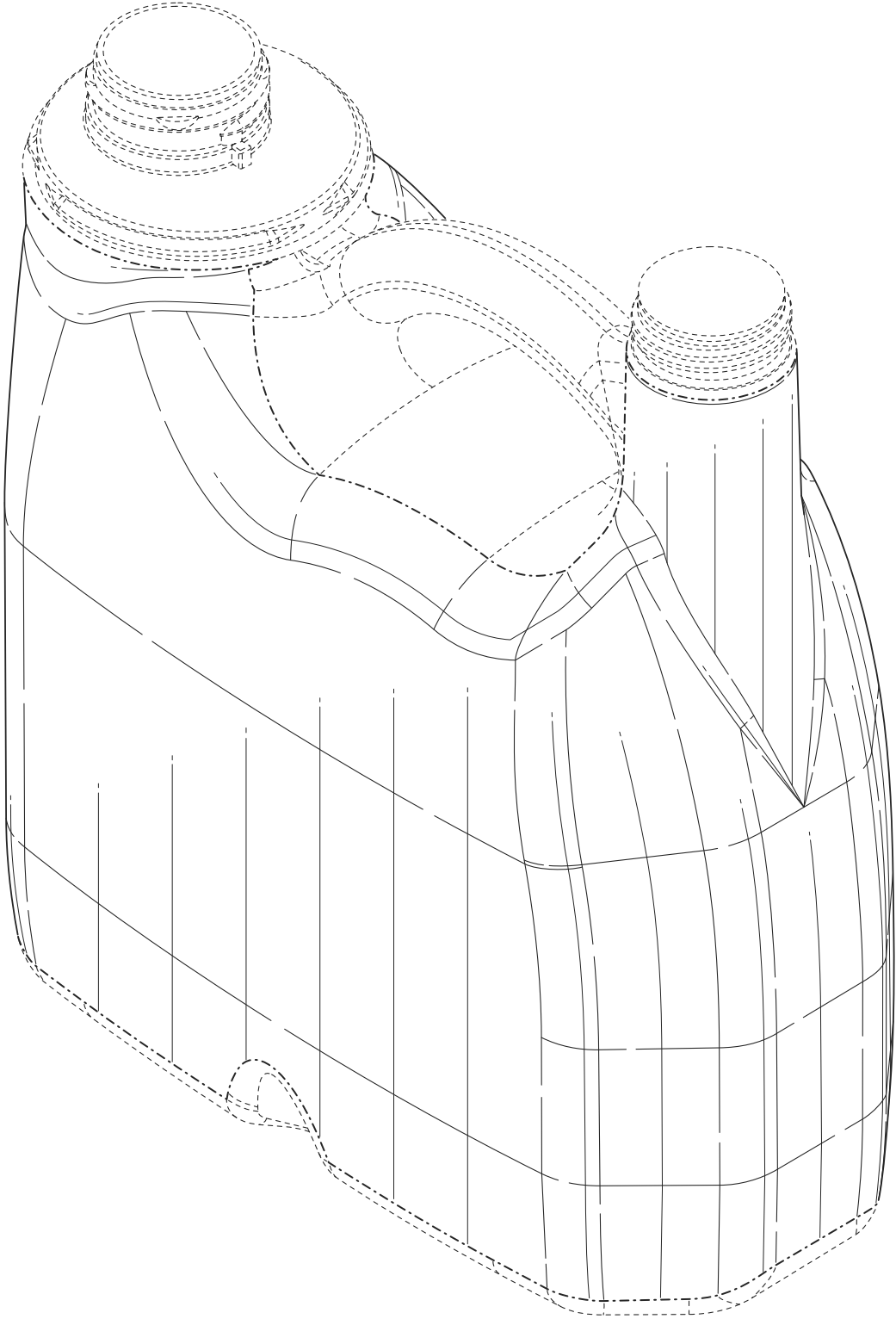

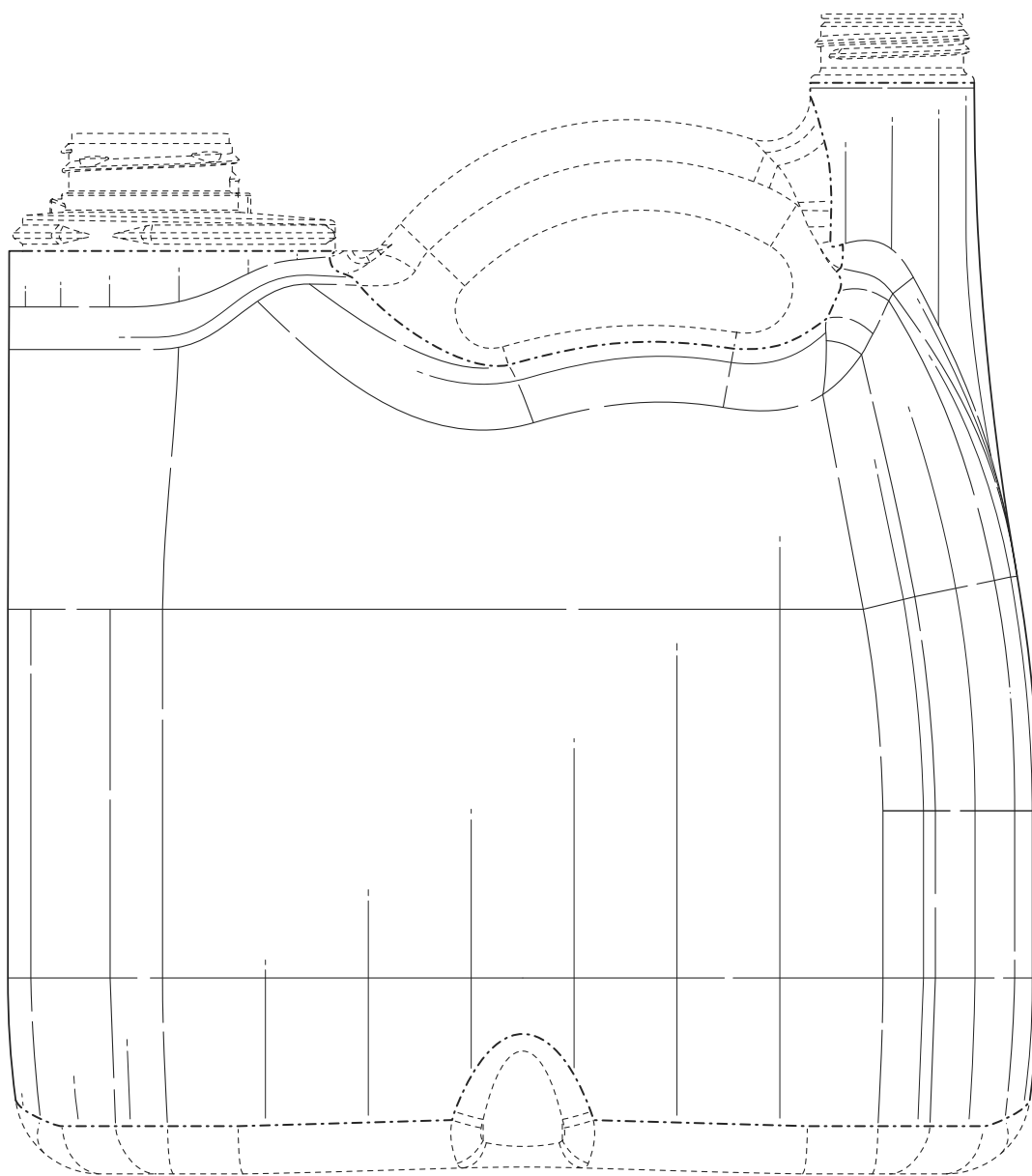

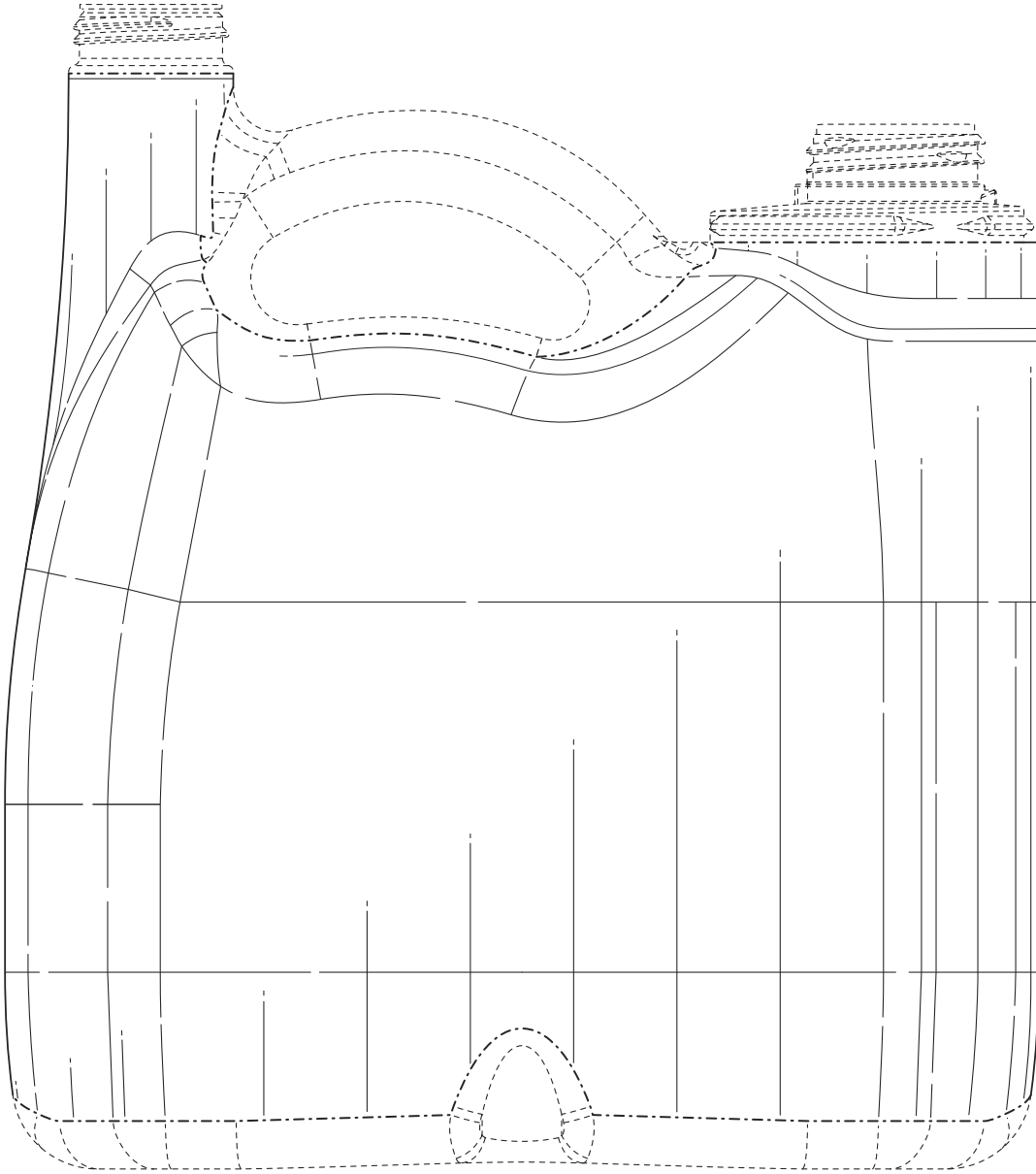

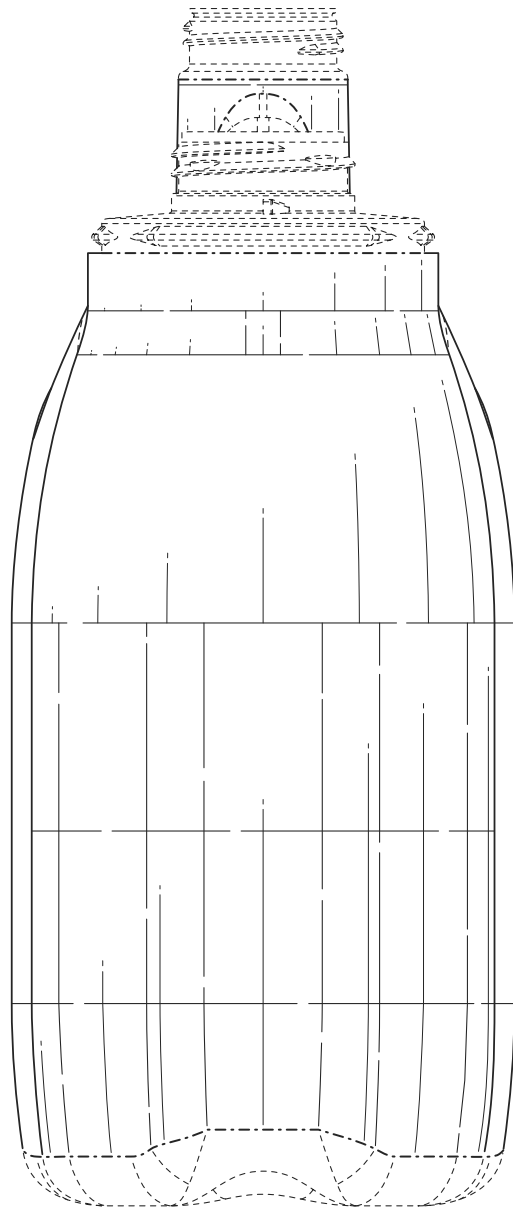

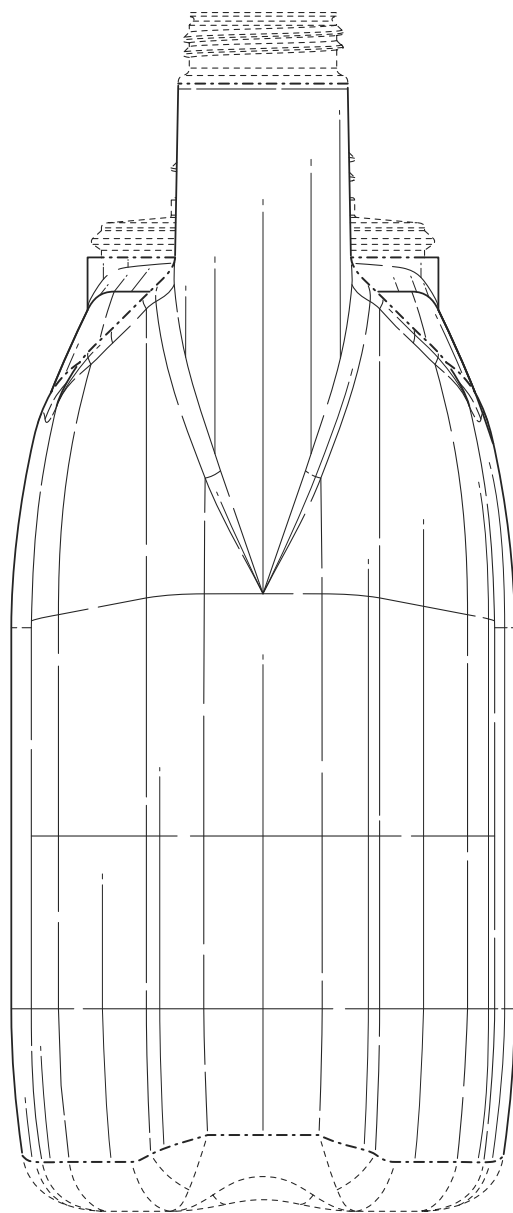

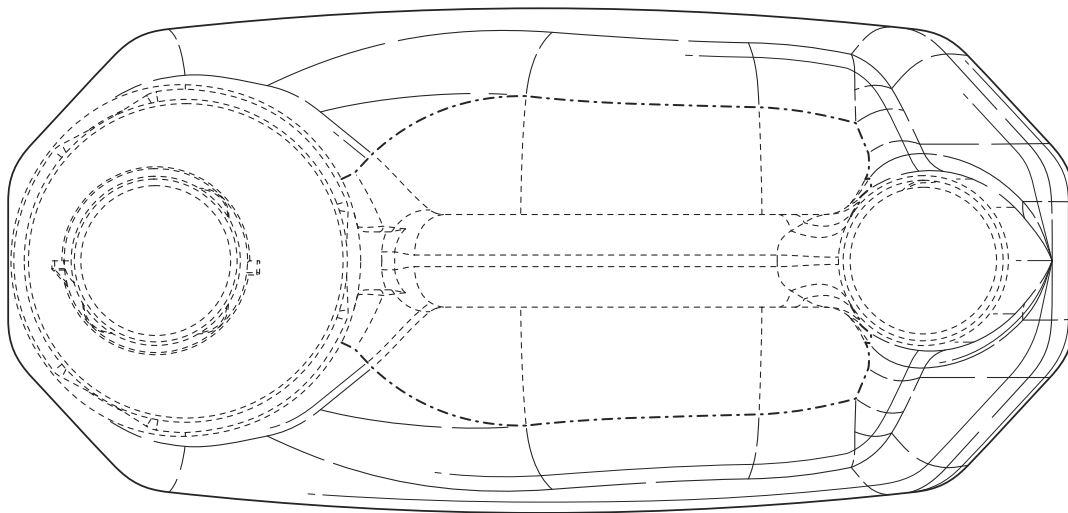

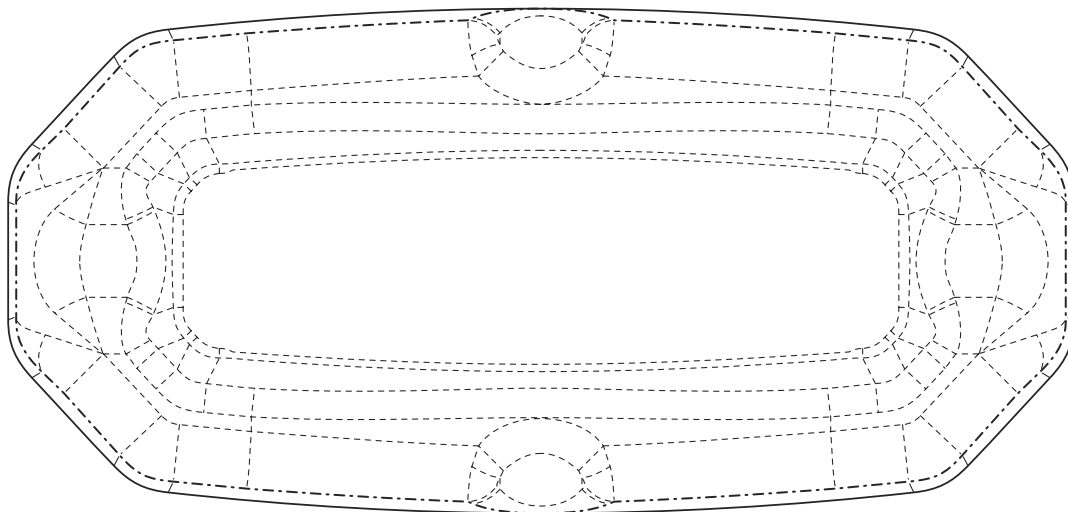

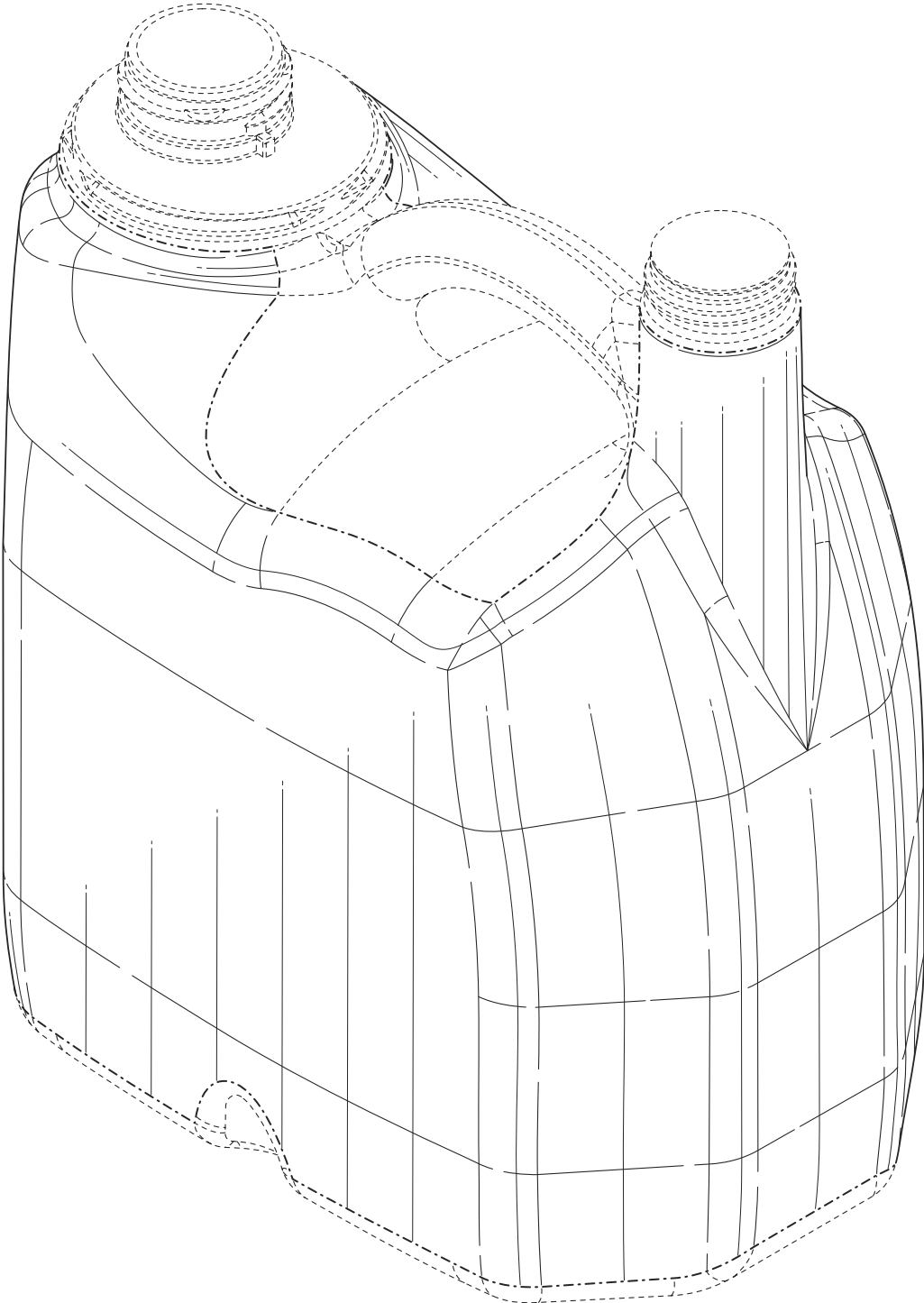

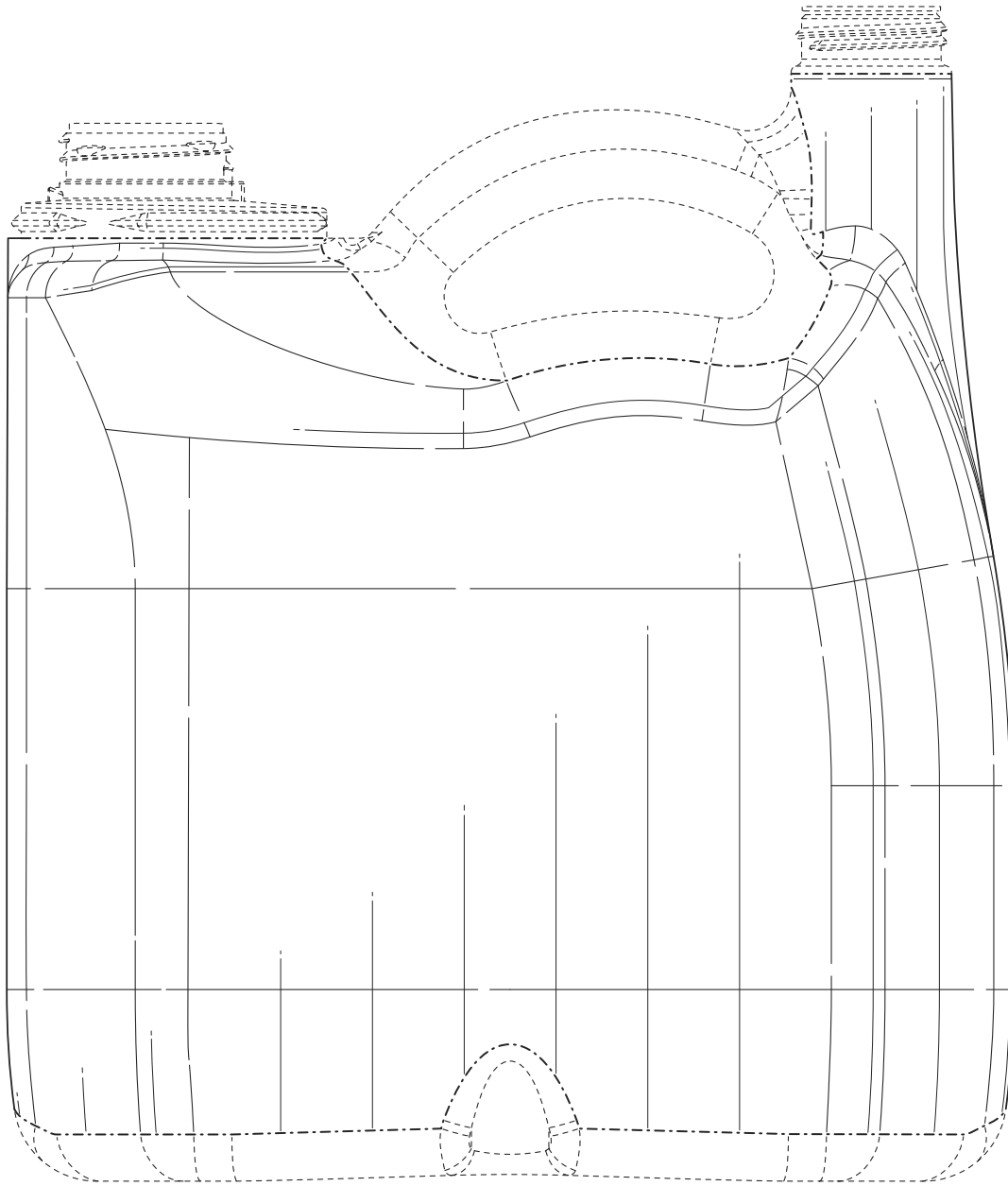

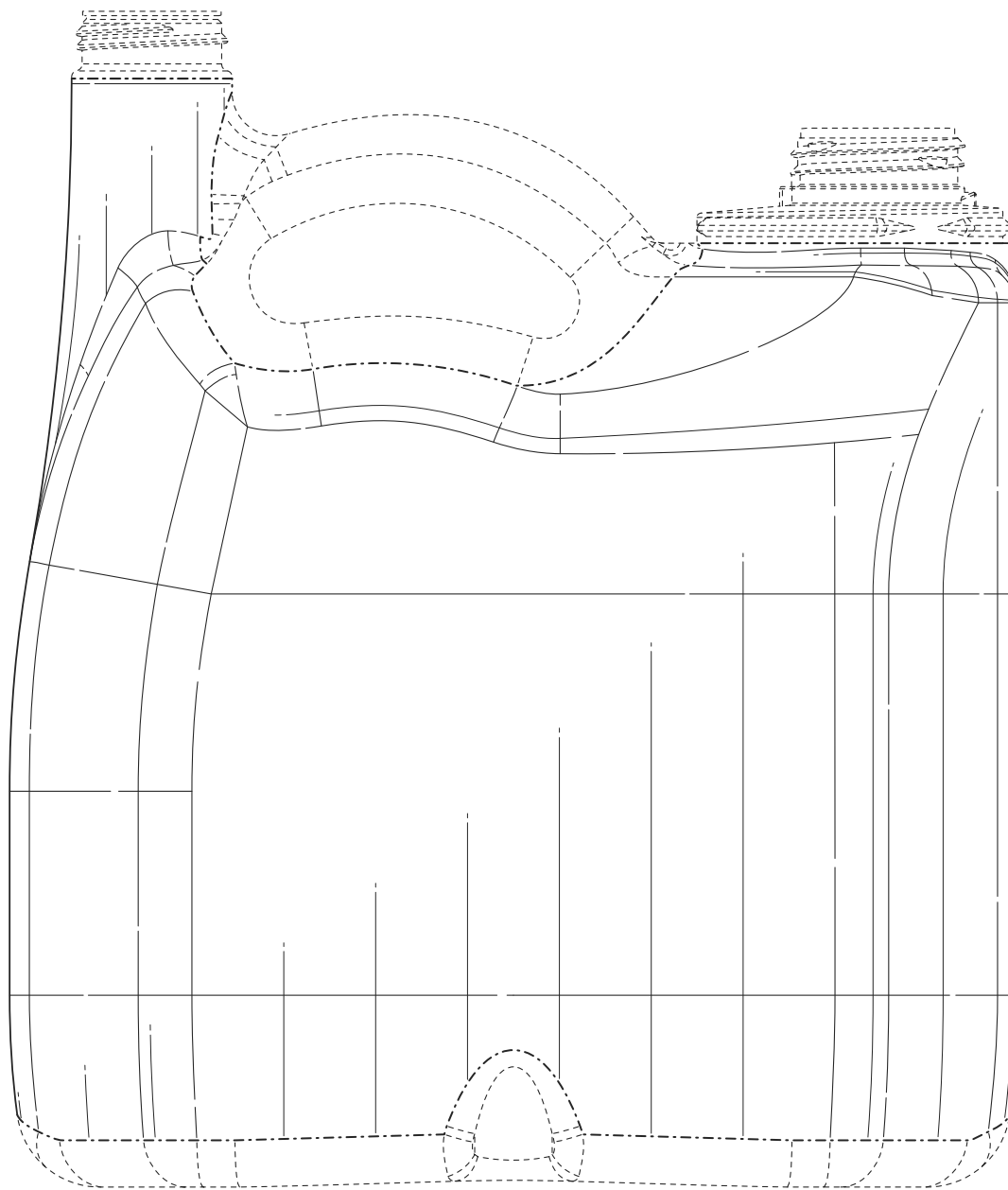

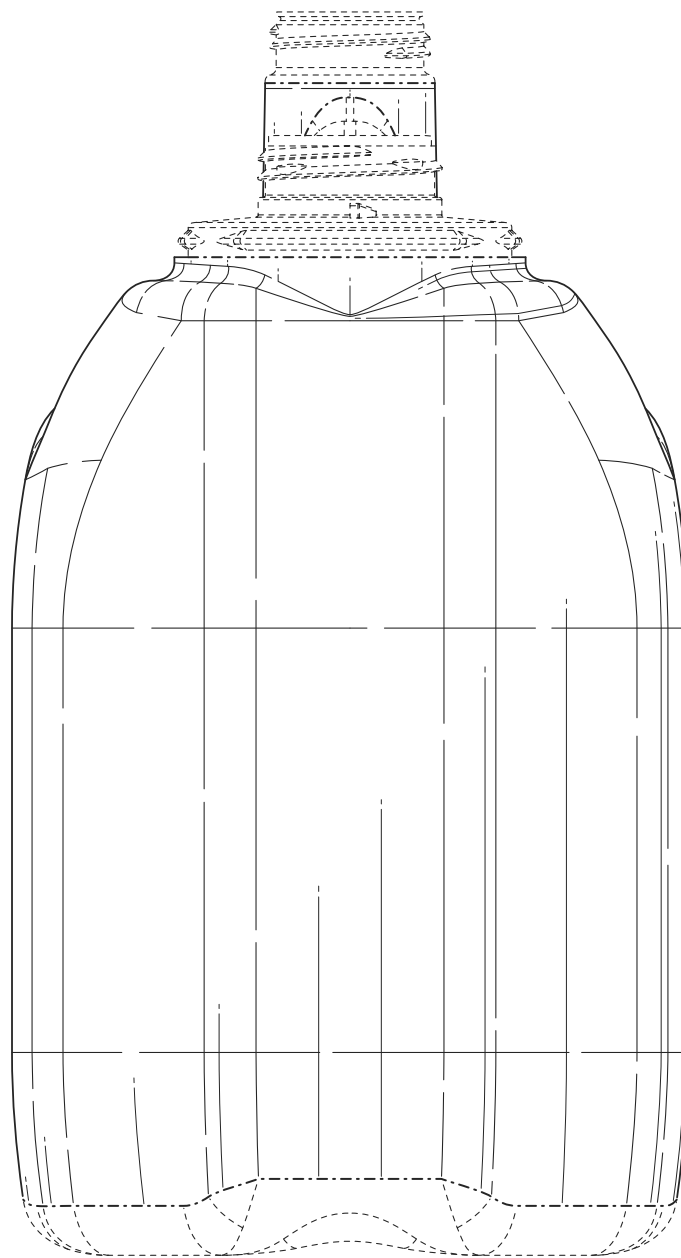

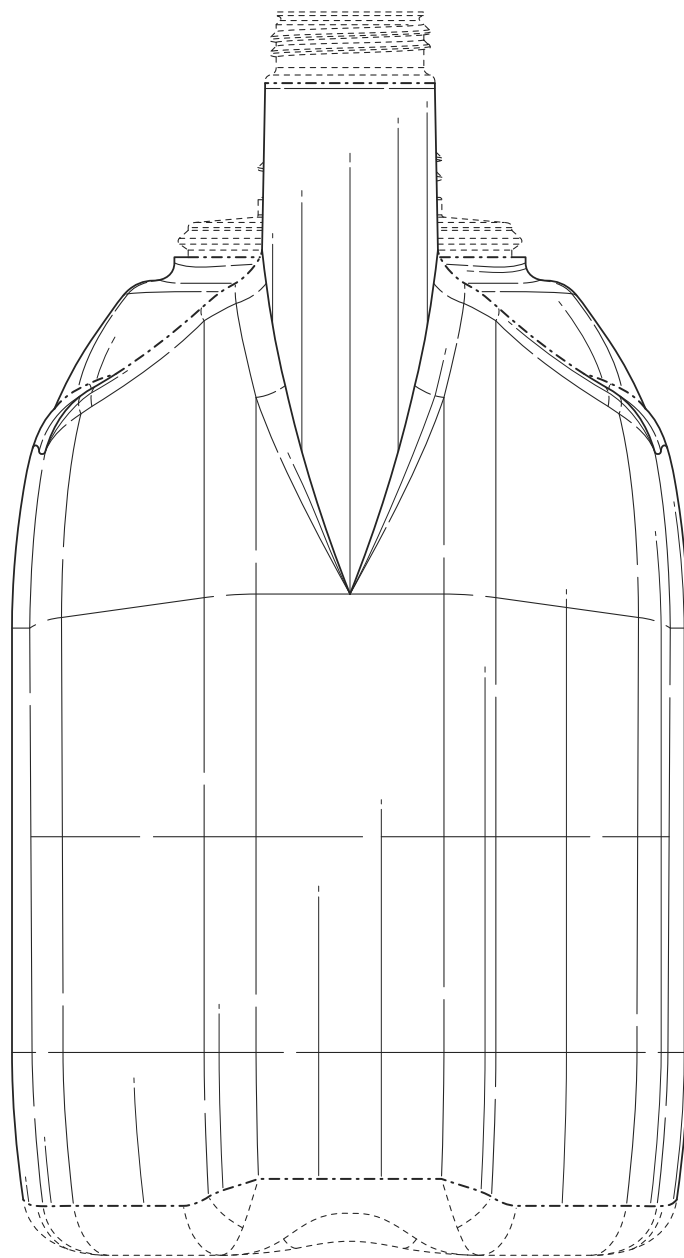

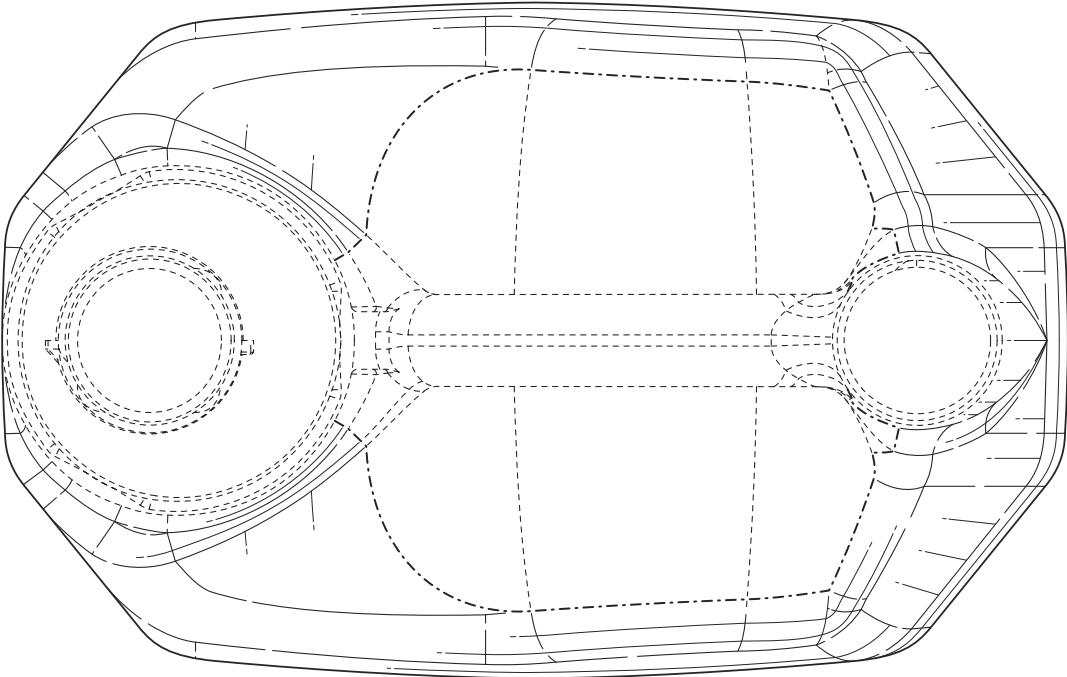

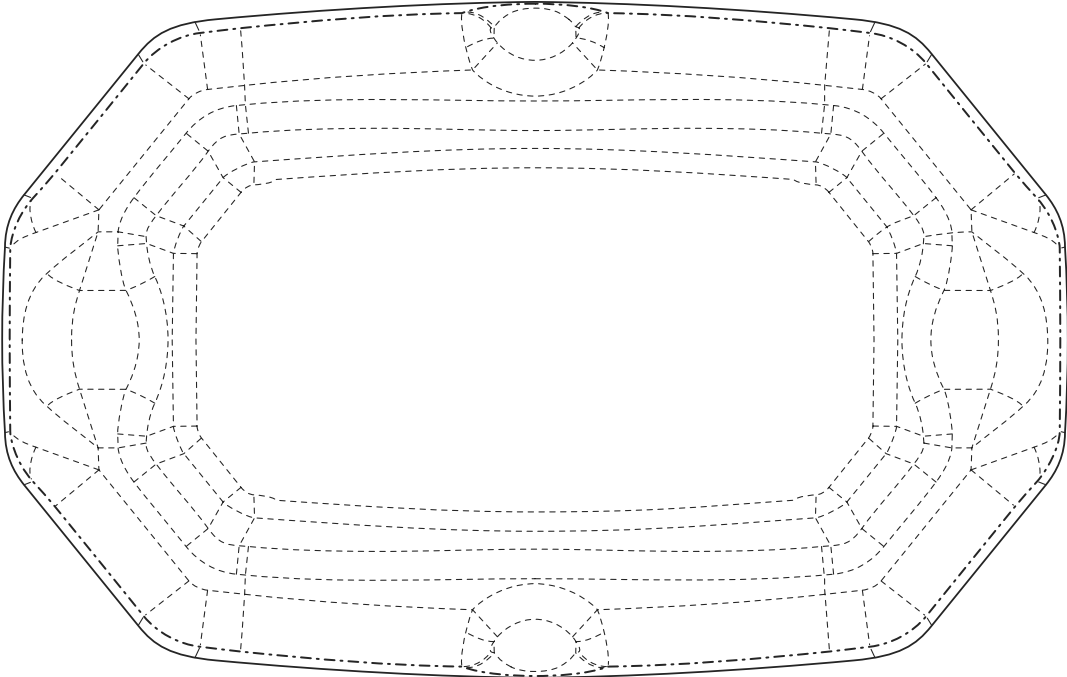
